RESOLUTION APPROVING THE BARANGAY GENERAL FUND SUPPLEMENTAL BUDGET NO. 01 FOR CY 2016 OF BARANGAY ZONE II, THIS MUNICIPALITY AS EMBODIED IN THEIR APPROPRIATION ORDINANCE NO. 01, SERIES OF 2016.

WHEREAS, a preliminary review was made on the Barangay General Fund Supplemental Budget No. 01, Series of 2016 of **Barangay Zone II**, Pinamalayan, Oriental Mindoro, appropriating the amount of Php 98,748.00 representing increase in barangay's share in IRA for the period of January to June, 2016.

WHEREAS, it appears that this budget has substantially complied with the existing budgeting rules and regulations, therefore, be declared operative and in effect as of the date fixed in the Ordinance for its approval subject, however, to the following conditions, to wit:

1. Payment of Mid-year Bonus shall be subject to the rules and regulations prescribed by **DBM Budget Circular No. 2016-3 dated April 28, 2016**;
2. The appropriations under the 20% Development Fund shall be consistent with the allowed capital expenditures per **DILG – DBM Joint Memorandum Circular No. 2011-01 dated April 13, 2011**;
3. The allocation of the 10% SK Fund shall be used by the SB solely for youth development programs or projects until the new set of SK officials have been duly elected and qualified and access to SK Funds shall be in accordance with RA 10632 and its Implementing Rules and Regulations (IRR);
4. The appropriation for Barangay Disaster Risk Reduction and Management Fund shall be in accordance with the approved BDRRMC Plan of the Barangay per Republic Act 10121;
5. Procurement of goods and services, infrastructure projects and consulting services shall be in accordance with the provision of Government Procurement Reform Act (R.A. No. 9184) and its Implementing Rules and Regulations (IRR);
6. The Punong Barangay is advised to go through the Standard Operating Procedures in the Planning and Budgeting process and submit the General Fund Barangay Annual Budget on time in compliance with Section 333 of Republic Act 7160 (a) "within then (10) days from its approval, copies of the Barangay Ordinance authorizing the annual appropriations shall be furnished the Sangguniang Panglungsod or the Sangguniang Bayan, as the case maybe, through thre city or municipal budget officer" (underscoring ours); and
7. Commission on Audit (COA) rules shall always be strictly adhered to relative to the disbursement of funds provided in this budget shall be the sole responsibility of the Punong Barangay concerned.
